→ SUMMARY

The President's Office of KPUM, throughout the tenure, drives forward a common goal amongst the committee of the Union, to achieve a greater and better KPUM. Through an equal collaborative effort between the members of the President's Office, we have managed, by the end of the tenure to execute our visions and objectives while simultaneously keeping the morale of the committee and ensuring its ongoing operations.

The President's Office also ensures that the affairs of the Union are in order, and keeps up to date on the goings of the Union at any possible time, whether the matter is big or small. Each member of the President's Office plays a role in the leadership of the different aspects and departments of the Union, with a particular emphasis on a supportive and cooperative dynamic amongst each of the Presidents and Secretaries.

Under the President's Office, new initiatives were implemented, and decisions were made as well to steer the Union forward in the changing circumstances of the world. Some notable achievements include the restructuring of online-based events to physical-based to cater to preferences, the diversity of students of different institutions in the Committee, and the structural change of the Shadow Programme to offer a more guided and in-depth approach. In addition, we undertook strategies and approaches to emphasize the consistency of branding and reinforcement of the Union's identity, such as having official letterheads for all Union documents.

For the tenure of 2023/2024, the President's Office co-led a Union of **88 committee members** across two divisions and **6 departments**.



GENERAL MEETINGS

EXTRAORDINARY GENERAL MEETING (EGM)

An Extraordinary General Meeting (EGM) was held virtually via Zoom on **16 September 2023** to address position vacancies following the 2023 Annual General Meeting. With 30 attendees, the quorum of 20 members was met.

The following individuals were elected to fill the vacant positions:

- Chong Jay Yi as Secretary
- Tan Jin Hao as Treasurer
- Mavvin Gobi Krishnan as Director, Career Development Department
- Puteri Qistina Aznir as Director, Skills Enhancement Department

A motion to amend the Union's Constitution, proposed by Chew Mingyih and seconded by Emilia Lye Jia Jia, was approved by a two-thirds majority. The revised Constitution, effective 16 September 2023, is now available to all members.

ANNUAL GENERAL MEETING (AGM)

KPUM's Annual General Meeting (AGM), held on **1 September 2024**, served as a pivotal event marking the conclusion of the 2023/2024 tenure. The AGM provided a comprehensive review of the Union's achievements and financial performance over the past tenure. A central feature of the meeting was the election of new office bearers for the 2024/2025 term, ensuring a seamless leadership transition.




MEMBERSHIP ENGAGEMENT

For the tenure of 2023/2024, the Union has executed **80 events and initiatives** for this tenure altogether, a slight step up as we have completely re-emerged from the COVID-19 era. Despite the larger amount of initiatives than the previous tenure, we ensured that the quality and value of the initiatives were not compromised for our Members.

However, upon observation from our membership engagement, which has only seen an increase in a few of the initiatives, we identified two challenges currently faced that are impacting the Union – namely, relevance and dilution of the pool of students. The issue of relevance would require the offerings of the Union to have a major shake-up to evolve along with the current legal landscape. Many new initiatives would have to be introduced to ensure novel opportunities. For example, our tenure has decided not to continue with webinar series due to its unpopularity as the world has rebounded from the COVID-19 era. As for the matter of dilution, due to many other similar initiatives and events held by various other bodies and organizations, the number of students is diffused, resulting in a reduced number of participants per event.

In addition, the President's Office maintained a system that monitored and enhanced the accountability of Members. This was effected by the introduction of the **Non-Attendance Policy** for our initiatives such as competitions and workshops. Members who registered for events but withdrew or failed to attend without valid reasons were subject to blacklisting. In our tenure of 2023/2024, **16 Members** were blacklisted.





DEMOGRAPHIC SURVEY

During our 2023/2024 tenure, we aim to maintain up-to-date records of our Members' diverse demographics. A survey conducted through our monthly newsletter received 171 responses in total, with 66.9% of members based in Malaysia and 33.1% in the United Kingdom and Ireland.

The survey revealed that 52.1% of members had not yet participated in any KPUM events. This underscores the importance of the newsletter in not only keeping members informed about upcoming events but also highlighting past initiatives to encourage greater participation.

The demographic survey also revealed member suggestions to include more mentorship programs and firm or court visits in the future. These recommendations will serve as valuable references for both the current and future tenures to ensure members' voices are heard and to strategically support their future career development.


EXECUTIVE PROGRAMME


The KPUM Executive Programme is an annual initiative overseen by the President's Office, designed to recruit executives into the Committee through a structured interview and screening process. The President's Office is responsible for managing the entire recruitment process and supporting the operations of the working committee. The Secretariat plays a crucial role in overseeing executive recruitment, including arranging interviews, coordinating with Directors from various departments, and providing support during interviews as needed.

Once recruited, Executives play an integral role in the successful execution of events throughout the tenure, collaborating closely with their respective Directors and Deputy Directors. Beyond operational responsibilities, Executives are encouraged to contribute innovative ideas and valuable insights in the planning and execution of events and initiatives, providing direct input to the leadership.

In an effort to increase participation and raise awareness of the Executive Programme in our tenure, we set up **promotional booths** at the main universities that offer law programs in Malaysia to encourage students to join the Union as Executives – **Advance Tertiary College KL (4 October 2023), Taylor's University (5 October 2023), and Brickfields Asia College (6 October 2023)**. This outreach initiative aimed to engage prospective members directly, providing them with information about the Union's mission and the valuable experience they can gain through the role as a KPUM Executive.

For the 2023/2024 tenure, we received an unprecedented number of applications for the Executive Programme, **totaling 123 applicants**, from which **70 executives** were recruited.





SHADOW PROGRAMME

The President's Office is in charge of initiating the Shadow Programme for potential nominees interested in running for the next Annual General Meeting (AGM) election. This programme provides participants with valuable insights into the workings of the respective departments and the Union as a whole by employing a shadowing system. The aim is to ensure a smoother handover process, regardless of the final pool of nominees.

By participating in this programme, candidates will gain practical experience and develop a pragmatic approach to addressing potential challenges during their tenure, should they decide to run, and ultimately win, in the election. The programme spans approximately two weeks, with each department's Director providing a separate agenda. Additionally, weekly virtual meetings are organized, offering Shadows a direct platform to engage with the Directors. During these meetings, Directors share their knowledge and experiences, including their motivations for taking on their roles as Director or Deputy Director within the Union's Board.

For the Shadow Programme of the 2023/2024 tenure, we successfully received a total of **32 applications** from candidates interested in various roles within the Union.



With an emphasis on unity and teamwork for this tenure, the President's Office has ensured numerous dedicated opportunities for the Committee to get to know each other and engage in team bonding activities via informal meetups, dinners, and activities. These sessions are designed to foster strong interpersonal connections, promote collaboration, and create a cohesive working environment.

COMMITTEE BONDING

The tenure kicked off with physical **Onboarding Sessions** for both the UK and Malaysia Divisions with interactive, challenging games where the Executives had to scour through **London** and **Kuala Lumpur** respectively to obtain clues to solve the puzzles. This was followed by an all-expense paid lunch/dinner, providing opportunities to bond over shared experiences and aspirations. Through fun, food, and fellowship, the onboarding sessions ensured that the Committee Members felt welcomed, valued, prepared, and united as they began their roles within the Union.



KPUM NEWSLETTER

KPUM Monthly Newsletter serves as an external key communication channel, offering Members a comprehensive overview of our past initiatives and upcoming events, as well as a bulletin board for other general information. In addition to that, it is a platform for parties in the legal field such as law firms and the judiciary to reach out to our Members for job vacancies and internship opportunities. This ensures that our Members are well-informed and actively engaged with the Union's events/initiatives and the legal offerings available, keeping all stakeholders connected with the Union's ongoing progress.

For this tenure of 2023/2024, the Union has revamped the KPUM Newsletter in terms of both content and design, making it more visually appealing and user-interface friendly. Since the launch of the Newsletter of this tenure, we have accumulated an additional 171 new subscribers to the previous tenure's existing subscribers, bringing this year's total outreach to **394 subscribers**. Despite the Union's huge amount of commitment and time constraints, we have managed to publish **4 issues** for our tenure.



INTERNAL MEMO

Understanding that whilst each Department focuses on its initiatives, there may be incidences of a department existing in its bubble within the Committee in terms of Union information. Hence, to foster inclusivity and to bridge the gap between departments, the secretaries have initiated the use of monthly internal memos to serve as ease of reference so that each committee member is updated and aware of the initiatives, ongoing and upcoming, of the other departments in the Union.

EXECUTIVE SUMMARY

The tenure of 2023/2024 saw a further increase in the Union's financial activity compared to the past two tenures as a result of the increase in the number of initiatives executed as well as their magnitude and substance.

Firstly, the Union's Total Income for this tenure amounted to **RM133,171.55**, comprised of Sponsorship Income and Other Income. Sponsorship Income is **RM125,018.55**; this constitutes a **13% increase** from the last tenure's income of **RM108,760.00**. Other Income included sales from Law Gala tickets, which contributed RM7,980.00, as well as refunds from vendors amounting to RM173.00.

Second, the Union had a Total Expenditure of **£14,360.22 (RM80,664.18)** for the **UK Division** and **RM65,488.12 for the Malaysian Division** in the tenure.


However, the main challenge currently faced by KPUM is the deficit for the fiscal year stemming from the huge costs of procuring venues for our main initiatives. Despite the financial shortfall, our tenure is able to remain financially stable with net positive balances for both the Malaysian and UK Divisions, while effectively supporting student activities and initiatives. Addressing the deficit will require strategic adjustments and enhanced revenue generation. Nevertheless, KPUM is committed to resolving these issues and continuing to support law student welfare effectively.





INCOME AND EXPENDITURE


KPUM Total Income tenure 23/24 = **RM133,171.55**





KPUM UK Division Expenditure tenure 23/24 = **£ 14,360.22**





EXECUTIVE SUMMARY

Being a core department of KPUM, the Careers Development Department (CDD) sought to bring each and every existing initiative to greater heights following positive feedback and interest from Members. The 2023/2024 tenure's initiatives of the department encompassed law career conventions, internship programmes, mentorship programmes, postgraduate law fairs, and CV drives.

A main driving factor and objective of CDD was the incorporation of more diversity and inclusivity for students both in Malaysia and in the UK. We have managed to especially extend CDD's initiatives reach to states outside of Kuala Lumpur, such as Johor, Penang, Sabah, and more.

The team brainstormed and implemented different strategies such as new and different elements into our initiatives to attract the attention of students and take a fresh spin off the usual career-type initiatives. This was partially achieved as well by downsizing certain initiatives from previous years that were less popular and less effective and re-focusing the effort on enhancing the flagship initiatives.

The result of the implementation of the strategies has proved to be great with many new attendees to the events both in virtually and physically in the UK and Malaysia.





LAW CAREER CONVENTIONS

An annual flagship of KPUM, the Law Career Conventions of the 2023/2024 tenure are large-scale events aimed at bridging the gap between students and employers. Following the success of the 2022/2023 tenure, a Law Career Convention was held in **London** on **24 March 2024** and in **Kuala Lumpur** on **24 August 2024**. These Law Career Conventions were held at the grand venues of **The Law Society** and **Cititel Midvalley** respectively. The opening keynote of the United Kingdom Law Career Convention was chaired by **Mr. Steven Perian KC**, a highly successful barrister in the UK with his roots from Malaysia.

Encompassing a whopping number of **19 participating organizations**, the 2023/2024 tenure has managed to fulfill its goal of bringing the best benefits to its members through providing opportunities for their careers all in one spot. Those that have attended the Law Career Conventions in the United Kingdom and Malaysia had overall found the opportunities and network presented to them extremely useful. The Law Career Convention managed to garner around 200 to 300 attendees respectively.

The Law Career Conventions, held in London and Kuala Lumpur respectively, have overarching themes of KPUM's history with enriching students throughout the years. Aptly, the Law Career Conventions also bring on discussions about diversity, equality and inclusion, especially in the context of Malaysian students. As an organisation that nurtures future generations of young Malaysian lawyers, the discussion of what the future holds, resonates more important than ever.



30 DAYS OF SUMMER INTERNSHIP PROGRAMME

Another annual flagship of the Careers Development Department, the 30 Days of Summer Internship Programme partners with various law firms from around the country to facilitate the process of securing internships for law students during the summer. The team this year managed to exponentially expand the traditional scope of the programme by including firms from the states of **Penang, Johor, Melaka and Sabah** for the first time in the history of the programme. This was done to bring awareness to the different types law firms outside of Kuala Lumpur and allow for students from these states to have an opportunity to perform an internship back home. Following the precedent from the previous tenure, students were given the opportunity to have their internship in periods between **June to September 2024** rather than the usual period of only July and August.




BEYOND THE BAR INTERNSHIP PROGRAMME

The Beyond the Bar Internship Programme is a non-law internship programme for law students designed for them to venture outside of the field of law in response to the rapid change of interests of law students today. Similar to the 30 Days of Summer Internship Programme, students have the opportunity to perform an internship with one of our partnering companies over the summer.

The Beyond the Bar Internship programme garnered 110 number of applications, which shows the growing interest of law students with careers outside the legal field.







MENTORSHIP BLITZ: A 6-WEEK ADVENTURE

A new initiative in exclusive collaboration with LAW Partnership, this initiative paired students with mentors to help them go through a series of prepared tasks aimed to help the students enhance their legal skills, from research to drafting and communication. A total of five mentors, Mr. Chen Yun Jin, Mr. Ashwinathan Selvanathan, Ms. Shivani Sivanesan, Ms. Nur Aliya Syaffa Binti Johari and Ms. Shazreen Sher, joined the initiative and they were each paired with two participants. Over the course of six weeks spanning March and April, the students were put to the test by tasks from KPUM, and had to submit their tasks for review by their mentors, whereas some tasks required the combined effort from the mentees and mentors.

The participants were also mandated to partake in a webinar as an extension of the initiative, titled 'Building and Sustaining a Legal Practice' to further enhance their legal knowledge. Speakers for the webinar include Mr. Choo Dee Wei, Ms. Jamie Wong and Mr. Lim Wei Jiet.

The initiative culminated with an exclusive evening physically at the LAW Partnership office with all the mentees and mentors to network and tie up the initiative.



UK POSTGRADUATE LAW FAIRS

The UK Postgraduate Law Fair is a collaborative event between KPUM and United Kingdom Education Centre. This law fair exclusively showcases UK Bar Training Courses from various institutions and legal education providers in the UK.

The Law Fair would consist first of a physical session at the **Asian International Arbitration Centre (AIAC)**, followed by a virtual session for the benefit of those students who are unable to attend the physical fair. For the physical sessions, individual booths were also set up for each institution, providing consultation opportunities for students to get advice and inquire about questions they are curious about in a more intimate setting to be able to make informed decisions on their postgraduate law pathways. It also consisted of different panels designed to engage with students who are unsure of what to expect from the bar courses.

For our tenure of 2023/2024, we are delighted to have collaborated twice with UKEC on this initiative, first on **2 December 2023** (virtual session on 9 December 2023) and the second on **21 July 2024** (virtual session on 3 August 2024).



KPUM x BAC NEXT GEN: LEGAL CAREERS OF THE FUTURE





Consequently, the 2023/2024 executive tenure for the Skills Enhancement Department (SED) has made it our mission to address the continuous demand for legal skill development and competence by further advancing our initiatives.

The Moot Competitions, our signature flagship, which needs no introduction, was held physically in both the United Kingdom and Malaysia, collaborating once again with Shearn Delamore & Co. and Lee Hishammuddin Allen & Gledhill respectively for another year. We took our highly successful 2-days-1-night Arbitration Camp initiative for another run, revamping it this round, making it bigger, better, and more substantial to accord participants a more beneficial and valuable experience. We boldly furthered that initiative by bringing it to the shores of the UK in an adapted version — Arbitration Day UK. Once again, we provided a platform for aspiring solicitors to learn how to draft a contract with our Contract Drafting Competition and its supplementary workshop. The annual collaboration with Shearn Delamore & Co led to an exceptional Moot Competition, a hallmark event for KPUM. The preliminaries were held online on **15 March 2024**, whereas, the Semi-Finals and Finals were held physically on **22 March 2024**. This competition tested the advocacy skills and legal knowledge of UK law students in a challenging simulated courtroom environment.

In preparation for the competition, Shearn Delamore & Co hosted a valuable **workshop** held on **24 February 2024** led by Partner **Mr. Jimmy Liew** and **Senior Associate Ms. Elisia Engku**. This workshop provided the **52 attendees** with foundational moot court skills, both substantive and procedural, which significantly enhanced the quality of competitors in the main event. Moreover, the previous winners of the competition were invited to expound on their experience as well.

With a **total of 44 registrants** for the competition itself, the preliminaries proceeded holding **32 participants**. The Semi-Finals and Finals took place at **University College London**, where the limited 15 spectator seats quickly filled up. 

This initiative had the pleasure of collaborating with the **Asian International Arbitration Center (AIAC)**, alongside active participation by lawyers from the esteemed firms of **Raja, Darryl & Loh** and **Mah-Kamariyah & Philip Koh**, as well as few other volunteering lawyers. Together, we brought about a wonderful event that addressed a field beyond the current legal syllabus.

*Dispute resolution has been a prevalently growing field of interest for many aspiring lawyers. Thus, the Arbitration Camp was designed as an opportunistic platform for students to immerse themselves in a 2-day-1-night crash course. We also proudly announce that the registrants for this year have surpassed its predecessor, hitting **98 registrations** from law students from various universities, with **32 students** shortlisted to partake in this coveted initiative.*

*Taking last year's Arbitration Camp's feedback from participants into consideration, this year's initiative expanded to include an online **Mentorship Programme** to provide substantive guidance for the participants to aid them in their written submission before the event day. The Mentorship Programme featured 8 mentors who were each paired to a team for **two weeks** leading up to the arbitration simulation.*

*On the physical camp days of the **2nd and 3rd of March 2024**, involving an overnight stay at **MPalace Kuala Lumpur**, participants were able to indulge themselves in a variety of activities, including two workshops, a specialized panel discussion, networking luncheons, and the most eagerly anticipated arbitration simulation. Each activity was crafted with the sole priority of providing the most*

knowledge in the shortest amount of time possible, all while ensuring the participants were to enjoy an enriching and memorable experience. We are most positive that the Camp has achieved its primary objective and that participants found themselves equipped with the fundamentals which would serve them greatly in future endeavours.

ARBITRATION DAY UK



With *Arbitration Camp Malaysia* a huge success and widely enjoyed by students, the 2023/24 tenure saw the initiation of the Arbitration Series, expanding it to the shores of the United Kingdom as *Arbitration Day UK*. This initiative was an inventive way to enable members of the Union in the United Kingdom to expand their knowledge on alternative dispute resolution, particularly Arbitration, as well as to participate in a mock submission of an arbitration proceeding that encompassed an arbitration problem, where participants were able to draw upon oral and written submissions. As this was a pilot initiative, *Arbitration Day UK* was executed on a smaller scale than *Arbitration Camp Malaysia* with just **14 shortlisted participants**.

In a similar fashion to its Malaysian counterpart this year, the initiative featured a 10-day pre-event **Mentorship Programme** for successful registrants, where they were allocated to their respective mentors who are legal professionals heavily involved in Arbitration. These mentors hailed from various law firms within Malaysia who graciously lent their effort and time in guiding the participants in their oral and written preparations. Prior to the competition itself, an insightful workshop titled **“The Moot Academy: A Workshop for Aspiring Advocates”** was proudly hosted by Partners **Mr. Chan Mun Yew** and **Mr. Amardeep Singh Toor**. Serving as a precursor to the main event, the session equipped its audience with the basics of moot, both substantive and procedural, which most likely was the reason for the elevated quality of competing candidates in the following competition.

Boasting a total of **24 teams** and **92 participants**, the competition kickstarted on 29 June 2024 with the Preliminaries and Quarter Rounds taking place at **Brickfields Asia College** with evaluation by **19 legal associates and Senior Associates** from the Firm. This was then followed by the Semi-Finals and Finals at LHAG’s home



office the following day, where limited spectators seats of 20 were instantly taken up to witness the final stages of the competition. CONTRACT DRAFTING COMPETITION



In collaboration with **SKRINE**

Following the success of the Contract Drafting Competition from the previous year, it was brought back for another run in the 2023/24 tenure and renewed in collaboration with Skrine. It offers Malaysian law students a practical platform to enhance their commercial law skills, which focuses on contract drafting and review, providing a real-world experience that goes beyond theory, sharpening participants' legal writing, research, and commercial awareness.

This submissions-based competition accommodates participants from both the United Kingdom & Malaysia, eliminating time zone constraints and welcoming law students regardless of their study year or prior experience in similar competitions. Registrations exceeded the previous tenure with **105 registrations** way before the closing of the registration deadline, where this year there existed a cap of **30 submissions**. The Judges were, Partner, **Ms Sheba Gumis**, Senior Associates, **Mr Tan Wei Liang**, **Ms Francine Ariel Paul**, **Ms Joey Tiw**, **Ms Beatrice Yew**, and Associates, **Mr Cheam Tat Sean** and **Ms Faith Chan**. The Best Teams were awarded cash prizes of up to RM 200, certificates, and internship opportunities with Skrine.

In tandem, an Info Session and Workshop titled, "**Guide to Contract Drafting: The Building Blocks**" was held on **22 June 2024**, featuring Senior Associates **Mr. Tan Wei Liang** and **Mr. Cheam Tat Sean**, and Legal Associate, **Ms. Faith Chan** from the Firm. This session, with **103 attendees**, offered beginners insights into contract drafting and competition details.



UKEC x KPUM LAW MOOT WORKSHOP

EXECUTIVE SUMMARY

The 2023/24 tenure saw remarkable growth and accomplishment for the Media and Communications department as it undertook strategic approaches to further amplify KPUM’s public presence as well as the visibility of its events and initiatives via effective digital marketing and communication strategies. The evidential significant increase in social media followers, heightened audience engagement, and exceptional content production levels have all contributed to KPUM’s growing presence both online and offline.

The 2023/24 tenure marked a record year for content production within the M&C department. In total, the team produced **63 promotional videos, 390 posters, and 453 additional creative materials**. This output represents a **210% increase** in the number of posters produced compared to the previous year, underscoring the department’s commitment to consistently providing high-quality visual content that aligns with KPUM’s branding.

The department’s approach in accordance with the tenure’s direction of consistency and uniformity in content design ensured that each event or initiative received its own set of posters, themes, cover pages, and templates, carefully tailored to align with KPUM’s **corporate design style and theme colors** of blue, white, and mustard yellow. Also, in line with the President’s Office’s direction of emphasizing the consistency of branding and reinforcement of the Union’s identity, the department was tasked with **revamping most existent logos and creating new logos** for new initiatives or for those that have never had their own.



In addition, the department undertook a dedicated effort to create the **KPUM M&C Handbook**, a compilation of the essential templates, color codes, and instructions, which we hope would benefit the M&C teams of future tenures.



Achievements in Social Media Engagement and Growth

The M&C department's efforts did not solely focus on increasing follower counts but also on deepening audience interaction. Over the last **90 days** of the reporting period, KPUM's Instagram account reached a total of **20,133 accounts**, a clear testament to the reach and visibility of its content. During the same period, the profile registered **9597 visits** and **1099 external link taps**, which indicates a strong level of interest in KPUM's activities and offerings.

In terms of direct engagement, the department successfully fostered interactions across posts, garnering **6258 likes**, **15 comments**, **633 saves**, and **233 shares** on Instagram. These statistics demonstrate that the content produced by the M&C department resonated well with the audience, fostering a sense of community and participation.



EXECUTIVE SUMMARY

The Human Rights and Activism Division (ASASI) remains the beating heart of KPUM's commitments to the rule of law and human rights. ASASI, therefore, acts as the human rights and activism wing of KPUM, championing human rights issues and taking a proactive stance in informing, engaging, and empowering our members and the wider community. This year, ASASI stands on the tagline **"Voice of the Youth"** as we champion the right to freedom of expression in youth spaces. In doing so, this year ASASI has introduced new initiatives, all aimed at empowering the youth in championing change and human rights.

We are proud that this year we have managed to bring back the Law Reform Competition after its 5-year hiatus. Our Activism 101 workshop with Impactworks additionally helped to serve as our pivotal initiative in generating community engagement and empowering our base. Furthermore, our *Dine with Us!* (In Collaboration With DariDapur) initiative was the first time ASASI had dipped into the issue of immigration and refugee rights on a physical and personal level. This year's ASASI's Internship Programme also introduced new organizational partners, adding on from the previous year, thus providing more diversity of choice for our applicants. Last but not least, our pilot initiative, the Malaysian Youth Activism Summit was a one-day summit featuring prominent speakers from various backgrounds in policy, human rights, and activism.

At ASASI, we believe that every voice matters, and through our efforts, we aim to make these voices heard in a world where we can openly express our views and opinions. Our goal stems beyond fighting for the cause of human rights, but to empower others to do the same.



HUMAN RIGHTS DAY FESTIVAL 2023

In conjunction with International Human Rights Day, the Malaysian Bar Council Human Rights Committee organised a Human Rights Festival at Lalaport on 10 December 2023. As part of our active engagement in human rights advocacy, the Union had set up an exhibition booth at the Festival where we had an expression wall which asked participants to answer “**How can we make Malaysia a home to all genders, races and religions?**”. We are happy to have received an overwhelming amount of feedback and positive responses.

ASASI also took the opportunity to promote and network with other human rights organisations present, promoting and advocating our efforts and forming new allies. Throughout the event, we were able to gain multiple fresh perspectives and form greater networks with other activists present on that day. Most importantly, we were able to share our work and what we do to people of different backgrounds.



LAW REFORM COMPETITION 2024

After its 5-year hiatus since 2019, ASASI is proud to have revived the Law Reform Competition for the year 2024. Whilst at a significantly smaller scale than previous iterations, the competition featured competitors from across different universities in Malaysia drafting policy reforms. In collaboration with the Malaysian Bar Council Civil Law and Law Reform Committee, along with additional support from the KLSCAH Youth Committee, Brickfields Asia College, and Zaid Ibrahim and Co, the month-long competition became a resounding success.



The competition was kickstarted in December 2023 where competitors were invited to participate in a physical workshop on the competition. Featuring previous winners of the competition as well as speakers well versed in law reform - Dr. Wilson Tay Tze Vern, Mr. Dineshwara Naidu, Mr. Wilson Pang, Mr. Afiq Mohd Noor, and Mr. Goh Cia Yee - the workshop provided a unique and informative experience to our participants present. With two themes being the focus of the competition: **Freedom of Expression** and **Sustainable Development**, the competition featured a preliminary round as well as a final round held in the month of January. Winners of each of the themes were given a RM150 cash prize as well as an exclusive internship offer at Zaid Ibrahim & Co.

ASASI X IMPACTWORKS: ACTIVISM 101 WORKSHOP



ASASI, in collaboration with ImpactWorks, conducted Activism 101 on 30 March 2024, a workshop that served as a sequel to the previous year's Grassroots Advocacy Bootcamp. This year, ASASI introduced its own module on activism and advocacy, aimed at providing participants with practical skills to create change.

The workshop emphasised the importance of base building to strengthen grassroots networks and sustain movements. It also explored how social media can be used as a powerful tool to amplify causes, engage with larger audiences, and drive impactful campaigns.

Activism 101 offered a hands-on approach, equipping participants with strategies to plan and execute successful advocacy efforts. By building on the foundation laid in previous workshops, this session continues ASASI's mission to empower individuals in championing social justice and advocating for meaningful change in their communities.

ASASI INTERNSHIPS

Operating in conjunction with KPUM's other Internship Programmes, ASASI's own brand of Internship Programme seeks to provide opportunities to students who are interested to be a part of organizations that work on matters relating to human rights. The internships with the partners usually have a length of one to two months.

The structure of the Internship Programme deviated slightly from the previous tenure, with the application separated from the other two Internship Programmes and made a standalone due to its nature and difference in commitment requirements and time periods. This was also done to ensure the participants genuine interest when signing up for the Internship Programme with ASASI through a demonstration of interest via the separate application rather than ticking a check-box in an all-included form.

In the 2023/2024 tenure, we partnered with **eight (8) organizations** that each represent a cornerstone of an element of Human Right matter. These organizations are **Teach for Malaysia, The Center to Combat Corruption and Cronyism (C4 Center), Suara Rakyat Malaysia (Voice of the Malaysian People, SUARAM), Justice for Wildlife, Centre for Orang Asli Concerns (COAC), Family Frontiers, Amnesty and Lawyers for Liberty.**

A total of **27 students** were provided opportunities with the abovementioned partners.

MALAYSIAN YOUTH ACTIVISM SUMMIT 2024

The Malaysian Youth Activism Summit (MYAS) stands as a new flagship project of ASASI. As part of the Union's manifesto for the 2023/24 term, the summit is designed to inspire and cultivate activism in today's youth. With the theme "**Empowering Youth for Change**", the summit deeply reflects the vision and mission of both KPUM and ASASI.

Held on 4 August 2024 at the The Chow Kit (An Ormond Hotel) to a full house, the summit boasted an array of speakers, activists and politicians who truly capture the essence of activism. At the core of the summit, the committee organised three main panels:

- (1) Shaping the Future with Activism,**
- (2) Different But Together: United Voices for Impact and**
- (3) Authenticity vs. Aesthetics: Challenging Performative Activism.**

In addition to the three panels, the summit also featured a "Youth Spotlight" where up and coming young activists were given a platform to promote their organisation and establish new allies and networks.

ASASI KINI

ASASI KINI is a rebranded initiative of KPUM that showcases matters that relate to or affect human rights or the rule of law, both internationally and in Malaysia, through a series of digestible bite-sized infographics. These infographics aim to bring awareness towards these issues that may otherwise be ignored or overlooked, as well as provide more context towards delicate matters that may at times be confusing.

ASASI KINI allows KPUM to bring undiscussed matters to light and encourage open dialogue over matters that may be deemed sensitive. In the 2023/2024 tenure, through the tumultuous and changing landscape of the world, ASASI has released 6 infographics:

1. How Student Voices can be suppressed.
2. Was Deputy Prime Minister Ahmad Zahid Hamidi's DNAA justified?
3. Protect the CCH judgment
4. The violence in Gaza has to end.
5. 50% off! Former PM Najib's Discounted Sentence.
6. Malaysia must halt the probe against local activists.
